KITEBOARDING, KITESURFING, SNOWKITING AND LANDKITING RELEASE OF LIABILITY, WAIVER OF LEGAL RIGHTS AND ASSUMPTION OF RISK

In consideration for the renting, purchasing or leasing of kiteboarding, kitesurfing, snowkiting or landkiting equipment from **iKite Canada Inc.** and/or utilizing the facilities, ground school, kiteboarding instruction, kitesurfing instruction, snowkiting instruction, landkiting instructions, premises, and equipment of **iKite Canada Inc.** in engaging in the sport of kitesurfing, kiteboarding, snowkiting, landkiting, ground instruction, water instruction, flight instruction and related activities (hereinafter collectively called "Kiteboarding"). I hereby understand and agree to this Release of Liability, Waiver of Legal Rights and Assumption of Risk and to the terms hereof as follows:

1. I acknowledge that Kiteboarding is an action sport and recreational activity involving travel in three dimensions and such activity is subject to mishap and even injury to participants. I understand I may suffer a broken limb, paralysis or fatal injury while participating in the sport of Kiteboarding. (Initial here _____)
2. I further acknowledge that there are no warranties applicable to the purchase, rental or lease of Kiteboarding equipment by me and that all warranties whether expressed or implied are excluded. THERE IS NO WARRANTY OF MERCHANTABILITY OR THAT THE SAID KITEBOARDING EQUIPMENT IS FIT FOR ANY PURPOSE, and that I am accepting the said Kiteboarding equipment as is and I hereby acknowledge that I will personally examine the said equipment prior to my using of the same. I hereby RELEASE AND DISCHARGE **iKite Canada Inc.** the province of Ontario, the Town of Thornhill, and their officer, directors, elected officials, agents, employees, instructors and owners of equipment and the land used for Kiteboarding activities (hereinafter collectively referred to as "Released Parties"), from any and all liability, claims, demands or causes of action that I may hereafter have for injuries and/or damages arising out of my participation in Kiteboarding activities, including, but not limited to, losses CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES. I understand and acknowledge that Kiteboarding activities have inherent dangers that no amount of care, caution, instruction or expertise can eliminate and I EXPRESSLY AND VOLUNTARILY ASSUME ALL RISK OF DEATH OR PERSONAL INJURY SUSTAINED WHILE PARTICIPATING IN KITEBOARDING ACTIVITIES WHETHER OR NOT CAUSED BY THE NEGLIGENCE OF THE RELEASE PARTIES. 5. I further agree that I WILL NOT SUE OR MAKE A CLAIM against the Released Parties for any injury, damages or other losses sustained as a result of my participation in Kiteboarding activities. (Initial here_____)
6. I also agree to INDEMNIFY AND HOLD THE RELEASED PARTIES HARMLESS from all claims, judgments, and costs, including attorneys' fees, incurred in connection with any action brought as a result of my participation in Kiteboarding activities. (Initial here_____)
7. I will take full responsibility for, and hold harmless Released Parties for any injury or damage that I may suffer or inflict upon others or their property as a result of my participation in Kiteboarding activities and engaging in Kiteboarding activities. (Initial here_____)
8. I agree that I will operate the said Kiteboarding equipment in a reasonable and safe manner so as not to endanger the lives of persons or property of any individual. (Initial here_____)
